AMENDMENT TO FEES FOR FIRST RESPONDER, AMBULANCE TRANSPORTATION FEES, MEDICARE AND MEDICAID SERVICES (CMS)

WHEREAS, on August 1, 2007, the Southern Marin Emergency Medical Paramedic System (SMEMPS) adopted a Fee Schedule which imposed fees for Basic Life Support (BLS) and Advanced Life Support (ALS) services; and

WHEREAS, the Centers for Medicare and Medicaid Services (CMS) has made a change in the Ambulance Service Fee Schedule and added items that may be billed to a secondary insurance company; and

WHEREAS, SMEMPS will be contemporary in billing practices set forth by CMS by adding these items.

NOW THEREFORE, BE IT RESOLVED, the Board of Directors of SMEMPS finds reasonable and necessary, and hereby adopts, effective August 9, 2021, the amended fees for First Responder, Basic Life Support and Advanced Life Support services as follow:
